

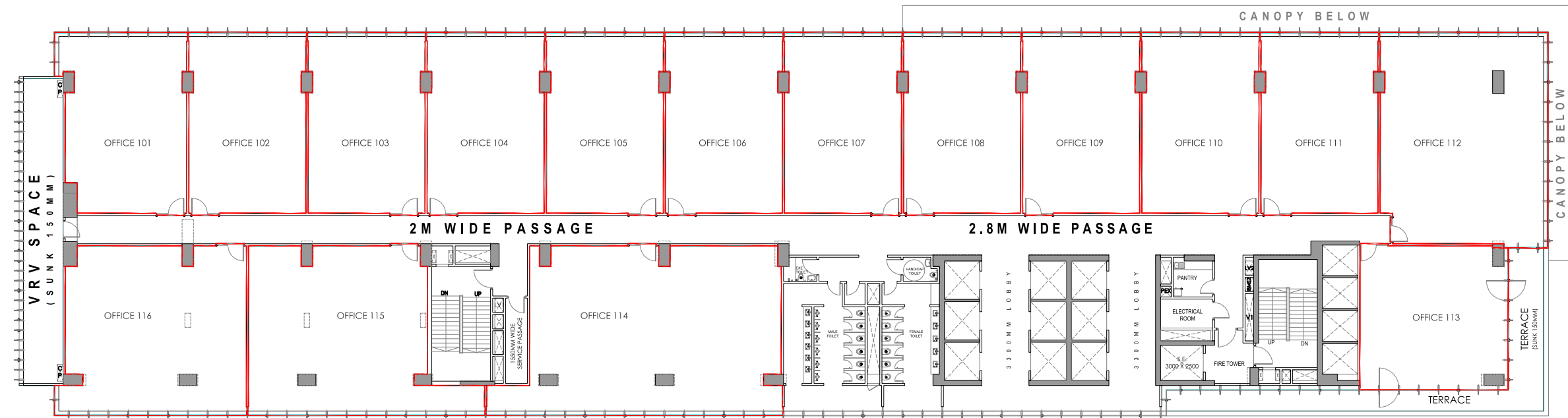

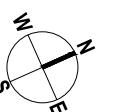

1ST FLOOR PLAN (MULTITENANT)

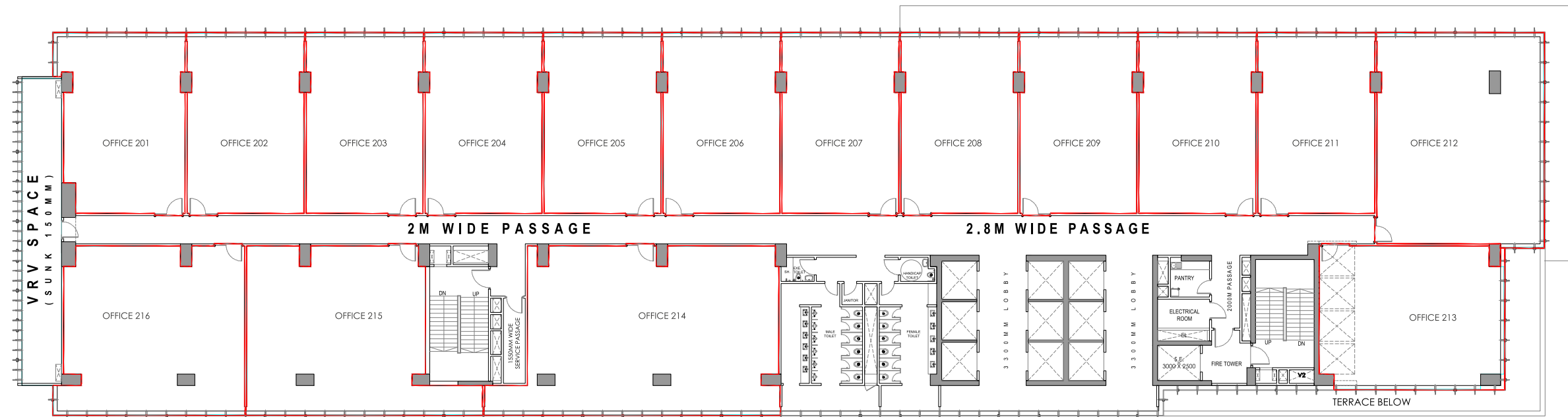

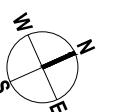


3RD FLOOR PLAN (MULTITENANT)

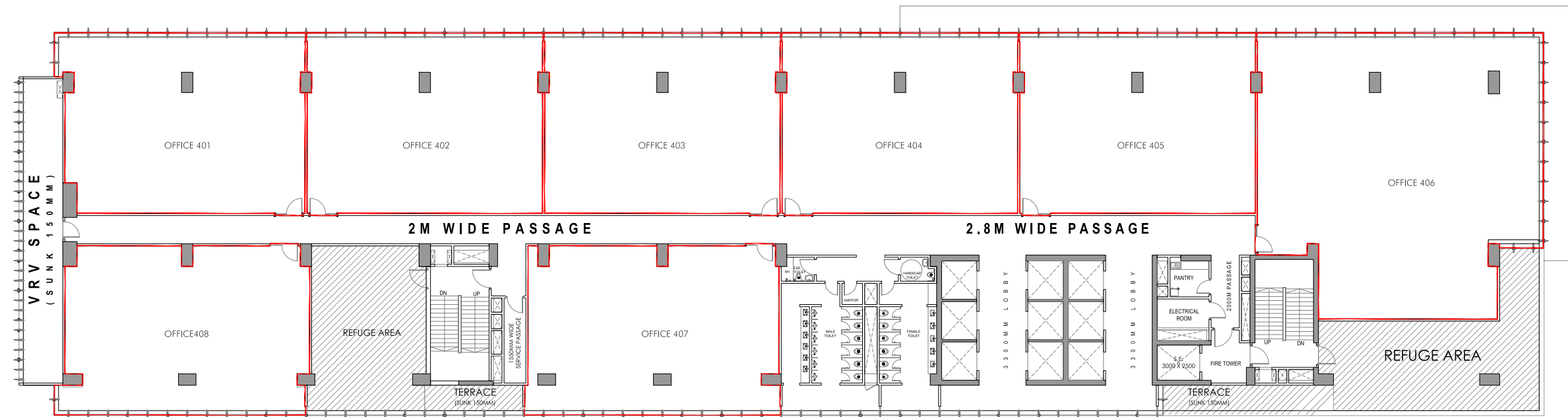

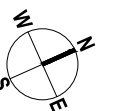


4TH REFUGE FLOOR PLAN (MULTITENANT)

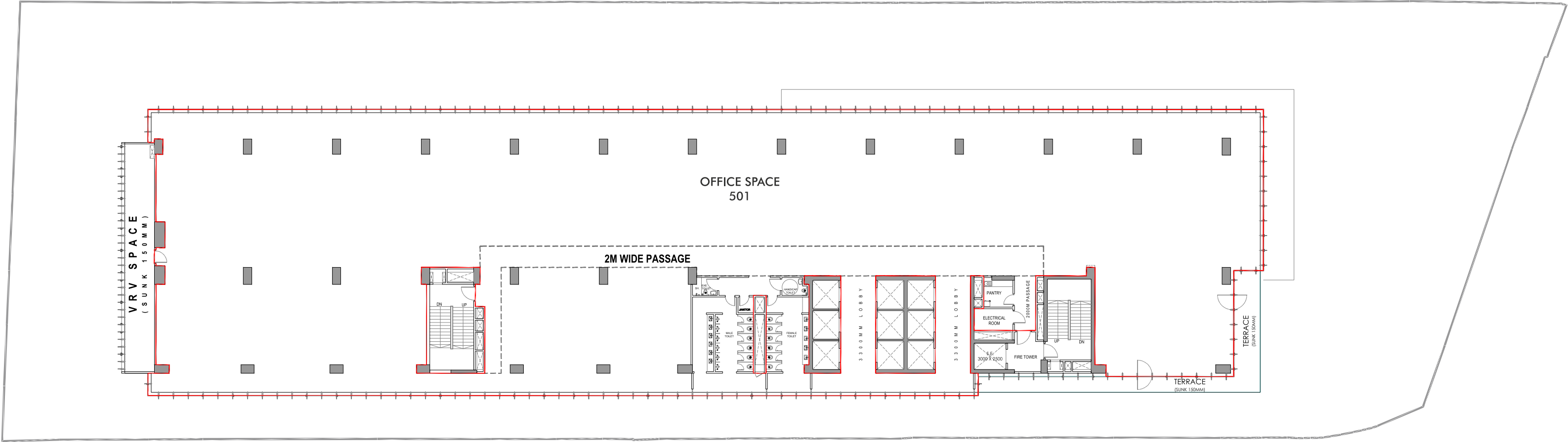

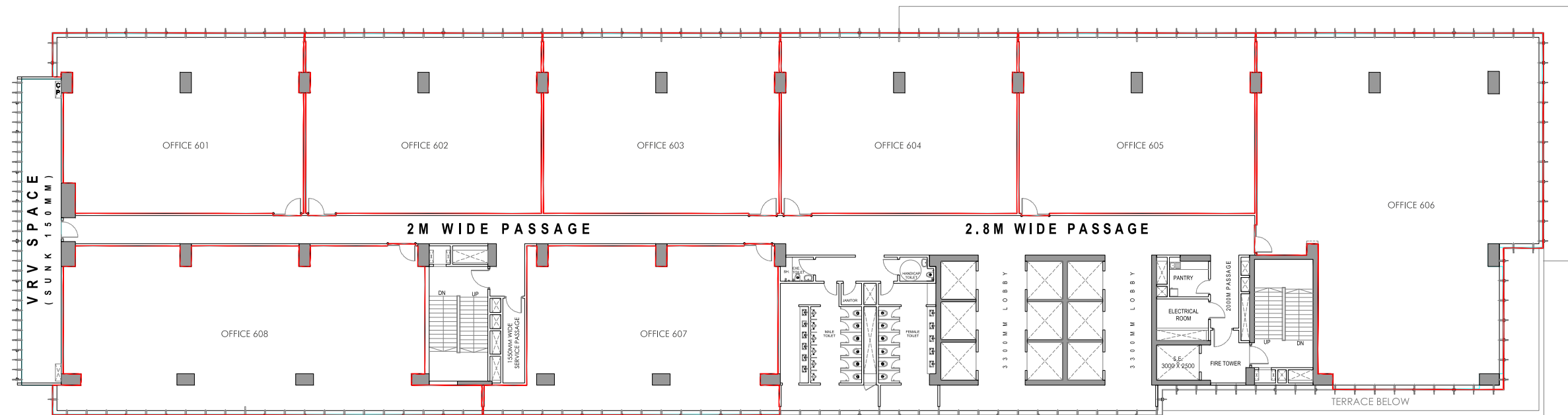


5TH FLOOR PLAN



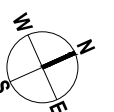

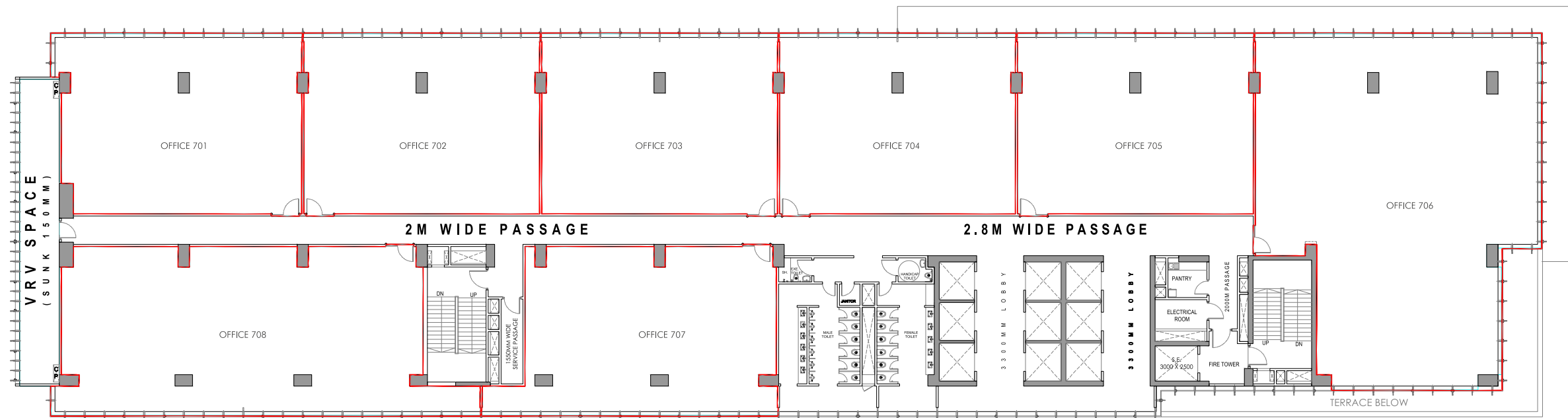

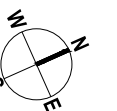


7TH FLOOR PLAN (MULTITENANT)

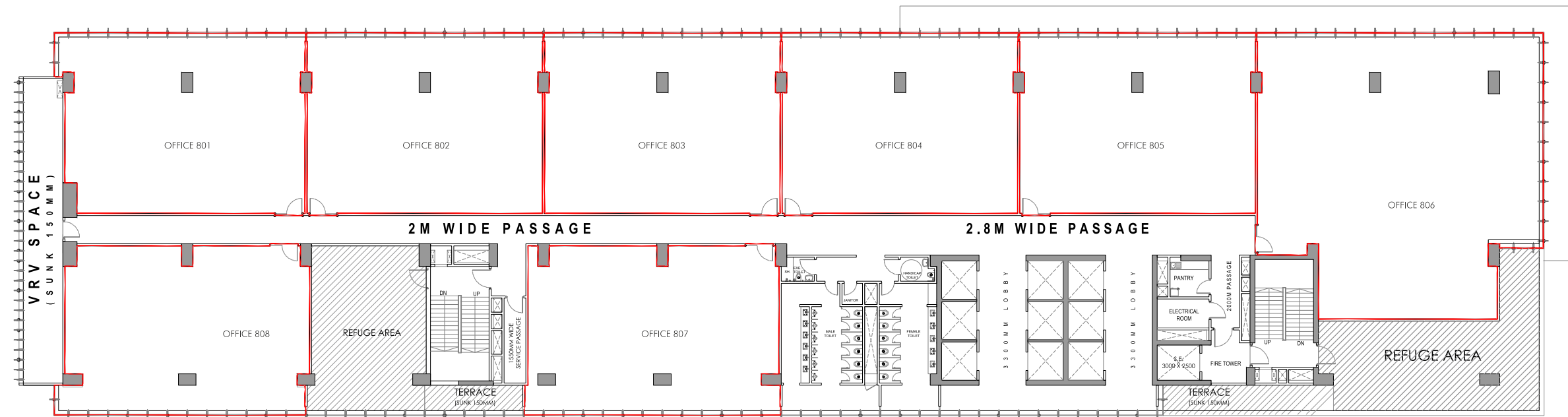

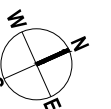


8TH REFUGE FLOOR PLAN (MULTITENANT)

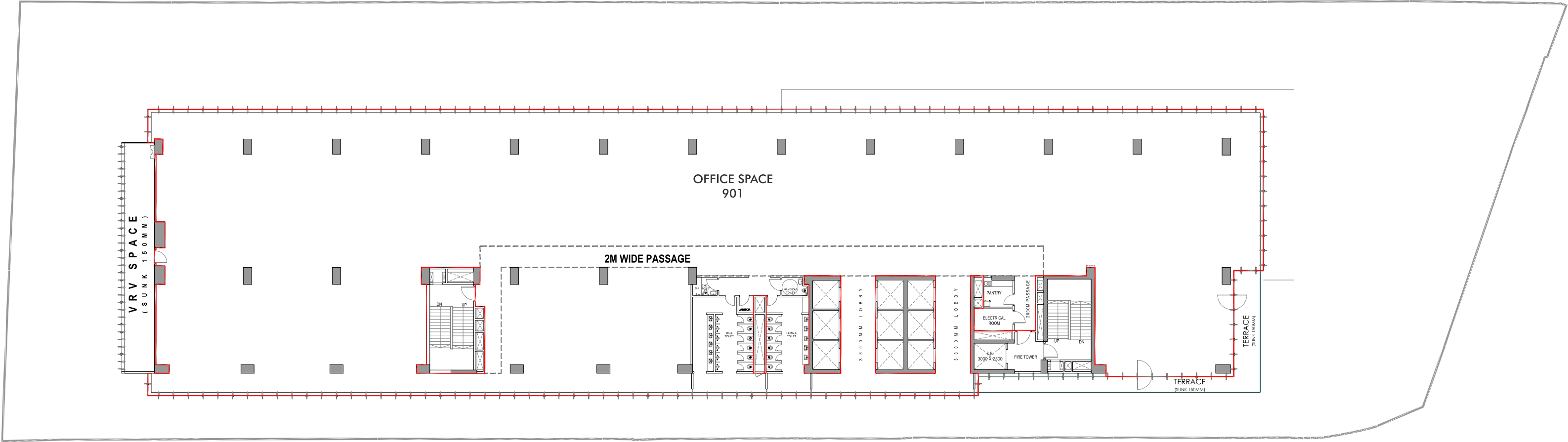

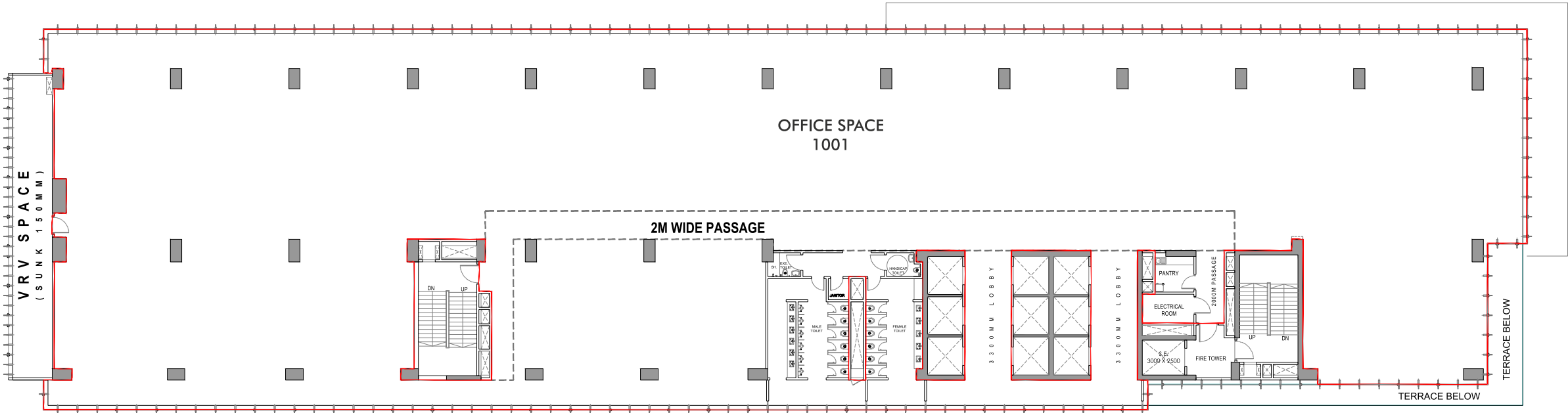


9TH FLOOR PLAN



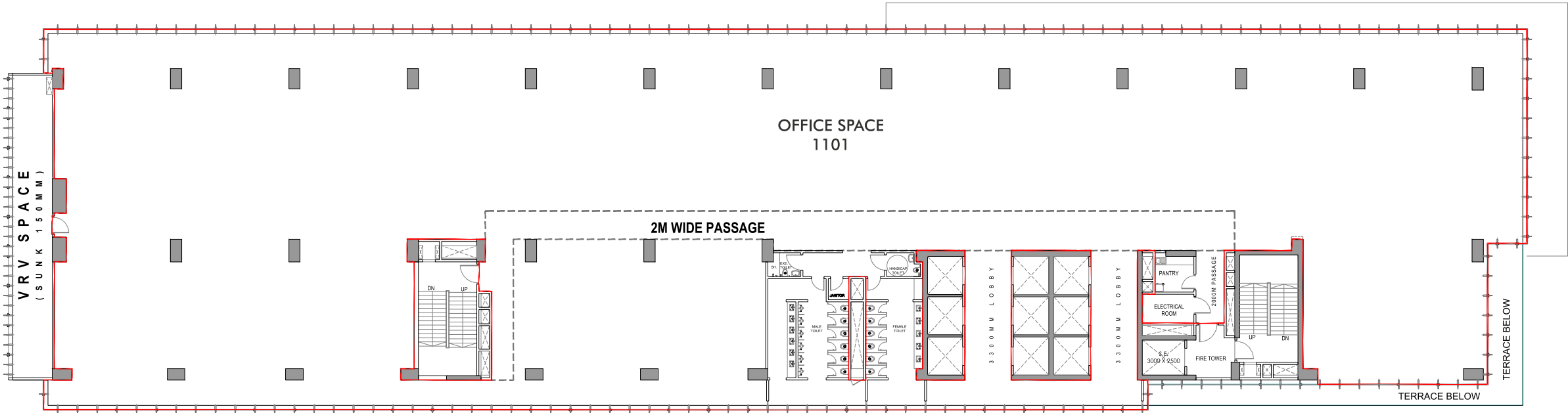

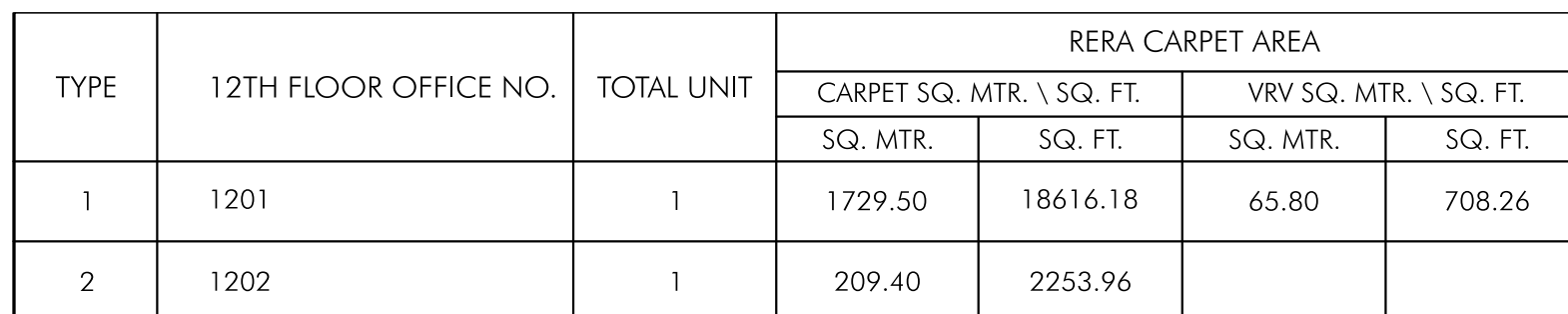

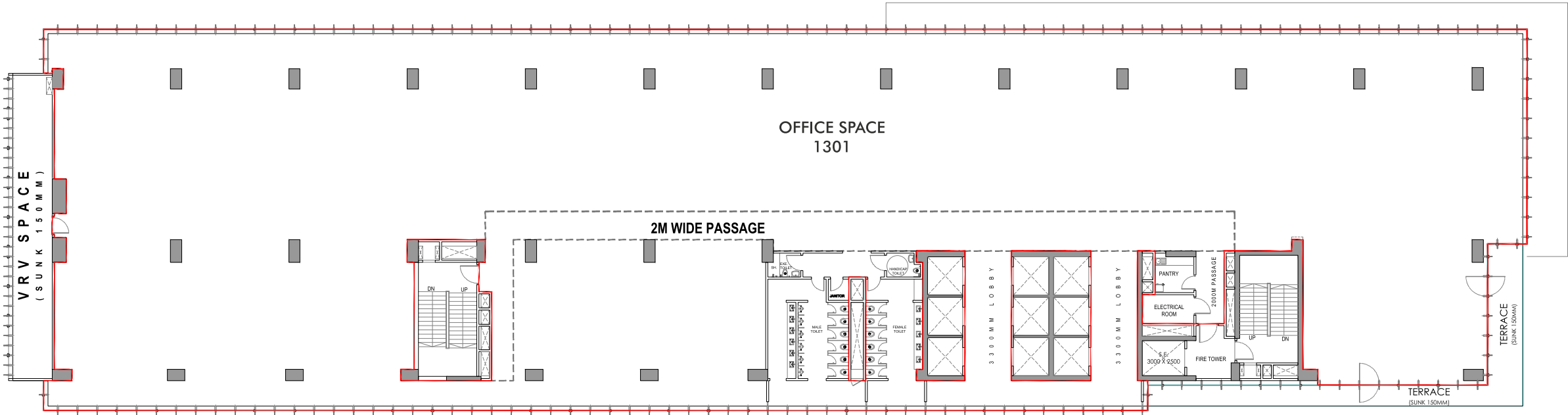

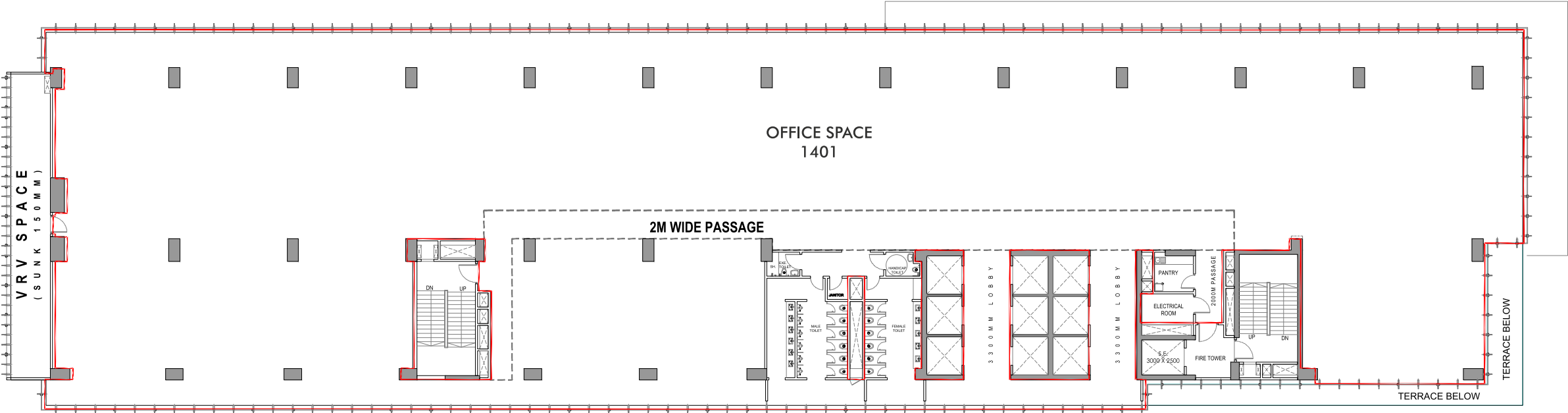


13TH FLOOR PLAN



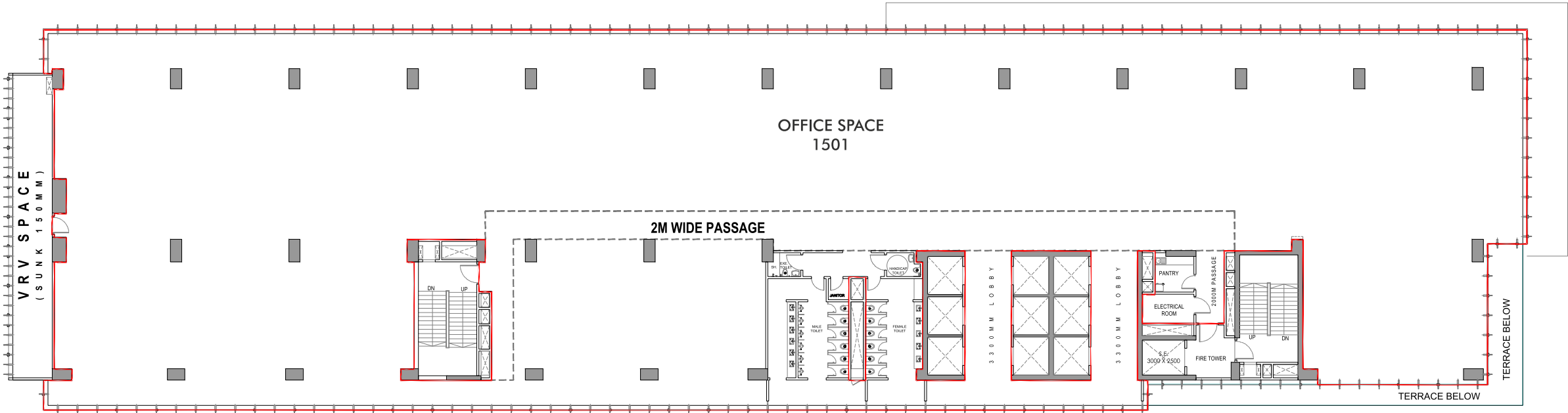

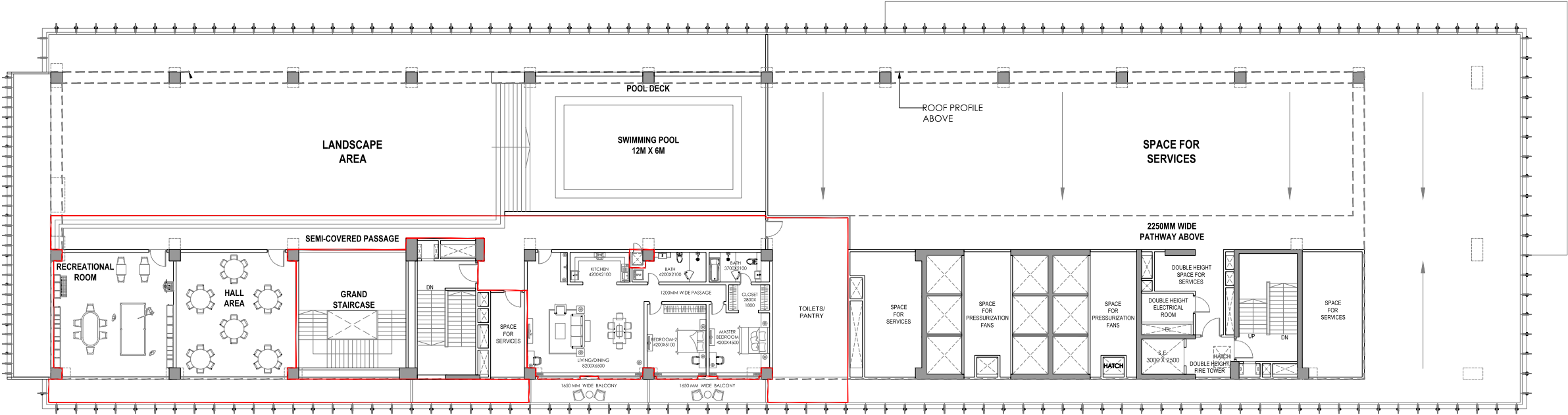
